Gemeinsame Erklärung der europäischen Berufsorganisationen der Gesundheitsberufe zu COVID_19

26 März 2020

Die Beschäftigten in Gesundheitsberufen schreien nach Ausrüstung!

Zwölf europäische Organisationen, die alle am Kampf gegen Covid-19 beteiligten Gesundheitsfachberufe vertreten, haben sich getroffen, um die aktuelle Situation in ganz Europa zu bewerten und die wesentlichen Erfordernisse zur Bewältigung der schlimmsten Gesundheitskrise, mit der die Europäische Union bisher konfrontiert war, aufzulisten, wobei bis heute mehr als 300.000 Fälle von COVID 19 im EU-Gebiet und im Vereinigten Königreich gezählt wurden.

Alle Berufsorganisationen der Gesundheitsberufe eint unter anderem dasselbe Problem: der Mangel an Persönlicher Schutzausrüstung in nahezu jedem Mitgliedsland. Die zu geringe Verfügbarkeit von medizinischer Ausrüstung (z.B. Beatmungsgeräte und ECMO-Geräte) wurde ebenfalls beklagt.

Es gibt einen überaus dringenden Bedarf nach mehr Ressourcen, um eine angemessene Personalausstattung sicherzustellen, sowie eine höhere Verfügbarkeit an Schutzausrüstung und medizinischer Ausrüstung. Es ist daher unerlässlich, bei der Überwachung und Unterstützung der Bemühungen der nationalen Regierungen und der Europäischen Kommission zusammenzuarbeiten, um sicherzustellen, dass die für die Behandlung von COVID-19-Patienten benötigten medizinischen Geräte und Medikamente für die Länder in kritischen Situationen zur Verfügung gestellt werden. Die EU muss priorisieren, dafür zu sorgen, dass alle Mitgliedsstaaten ihre Ressourcen zusammenführen und die Präventionsprotokolle harmonisieren, um den Schutz von Leben zu gewährleisten.

Darüber hinaus halten wir es für unerlässlich, dass die Testkapazitäten erhöht werden, damit das gesamte in unseren stationären und ambulanten Diensten und Einrichtungen tätige Personal die Möglichkeit hat, sich gegebenenfalls auf das Corona-Virus testen zu lassen.

Auch in Zeiten der Krise müssen angemessene Arbeitsbedingungen gewährleistet werden. Die Mitarbeiter/innen müssen Pausen und Ruhezeiten zwischen ihren Schichten erhalten, denn nur so werden sie in einer möglicherweise lange andauernden weltweiten Krise durchhalten können. Unter solchen Bedingungen arbeiten zu müssen ist eine enorme Belastung für die psychische Gesundheit der Mitarbeiter/innen, deshalb muss auch hierzu für geeignete unterstützende Dienste gesorgt werden.

Und schließlich: Die europäischen Berufsorganisationen fordern die EU-Kommission auf, einen Dialog mit den Europäischen Gesundheitsberufen zu eröffnen, um Erfahrungen und Gute Praxis in ganz Europa untereinander zu teilen und sicherzustellen, dass sich die eigenen Unterstützungsmaßnahmen der Kommission auf die operativen Prioritäten vor Ort konzentrieren.
